LETTER FROM THE EXECUTIVE DIRECTOR

Wildfire is a fact of life here in western Colorado. West Region Wildfire Council's work to increase resilience within our communities and cherished landscapes remains as pressing as ever. Over the past year, our staff worked in tandem with many partners to assess and identify wildfire risk to a variety of values through community wildfire protection planning (CWPPs), rapid wildfire risk assessments, home assessment "site visits" as well as other forms of collaborative forest and community assessment and planning processes. All of this is done with our many local, state and federal agency partners.



When thinking about wildfire, what are the values at risk that matter to you? Maybe you're concerned about a wildfire affecting your home or your business. The program and its standards have been endorsed by a variety of local and statewide partners, and I fully anticipate that it will become the preeminent wildfire mitigation certification in western Colorado. In addition to offering peace of mind for certificate holders, our intent is to work with representatives from the real estate and homeowner's insurance industries to recognize and promote the Wildfire Ready Home Certification. There are many exciting projects, programs and opportunities ahead for the West Region Wildfire Council, and I hope that you will consider getting involved and joining us as we "Work together to reduce wildfire risk"!

HELPING REDUCE RISK FROM WILDFIRE

West Region Wildfire Council staff help prepare people, communities and watersheds for wildfire to reduce the risk to life, property, and the places we love.

COMMUNITY AND PARTNER ACTIVITIES

WRWC staff facilitate and participate in collaboratives to plan landscape-level strategies to improve resiliency to wildfire. We also partner with communities and provide education, assessments and recommendations.





ACRES TREATED

West Region Wildfire Council invested \$671,334 in vegetation management projects with the support of many partners. 39 projects were completed plus 19 followup seedings. Participating landowners matched this investment with \$301,814 in cash and in-kind contributions of \$57,043.

WILDFIRE RISK ASSESSMENTS

WRWC staff provided 169 free site visits to homeowners. Homeowners received a report detailing recommended actions to help reduce the risk of wildfire damage. We also conducted over 1,000 rapid risk assessments!





In 2023, WRWC spent \$1,312,324 on mission-driven work. WRWC specializes in aggregating federal, state and local funding to manage and deliver wildfire mitigation programs that are rising in demand. In 2023, WRWC was awarded \$2,198,356 in competitive federal and state funding to support our Vegetation Management and Wildfire Adaptation Programs between 2023 - 2027. WRWC secured an additional \$140,101 in local funding support from our county partners that will be used over multiple years.
